

**SUMMARY ANNUAL REPORT FOR
PRESBYTERIAN HOMES AND SERVICES EMPLOYEES RETIREMENT SAVINGS AND INVESTMENT PLAN**

This is a summary of the annual report for the PRESBYTERIAN HOMES AND SERVICES EMPLOYEES RETIREMENT SAVINGS AND INVESTMENT PLAN (Employer Identification Number 41-0758756, Plan Number 006) for the plan year 01/01/2016 through 12/31/2016. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance contracts. Plan expenses were \$2,615,566. These expenses included \$451 in administrative expenses and \$2,542,312 in benefits paid to participants and beneficiaries, and \$72,803 in other expenses. A total of 6946 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$38,540,500 as of the end of the plan year, compared to \$34,974,091 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$3,566,409. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$6,181,975, including employer contributions of \$3,348,089, employee contributions of \$0, and earnings from investments of \$2,175,066.

Minimum Funding Standards

Enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.
